MEETING MINUTES  
February 19, 2021**

**CALL TO ORDER:** The meeting was called to order at 4:00 p.m. by Village Clerk Braunschweig.

**ROLL CALL:** Members Shirley Ehlert, Norine Janzen, David Rampson and Village Clerk Braunschweig are all present. Deputy Clerk Hubrich was also present.

**CANVASS OF 2021 SPRING ELECTION - MUNICIPAL RESULTS:** The Board of Canvassers reviewed the results for the Spring Primary Election held on February 16th, 2021 in the Village of Germantown.

**District 2, Wards 2, 5, 6 and 7:** The total number of cards cast in District 2 was 349. The total number of votes cast for Village Trustee in District 2 was 320 votes, of which:

Kevin Schodron received 90 votes.

Bill Neureuther received 153 votes.

Peter Source received 73 votes.

The Municipal Board of Canvassers Summary Statement and Certification declared the following persons as receiving the greatest number of votes for Village Trustee in the District Two on February 16, 2021, Spring Primary Election:

Village Trustee – Kevin Schodron receiving 90 total votes.

Village Trustee- Bill Neureuther receiving 153 votes

Lots were drawn for placement on the Spring Election ballot.

**Motion (Janzen/Ehlert) to approve the placement of names on the Spring Ballot and to certify the results of the Spring Primary Election. Motion carried unanimously.**
