Once completed there will be a distribution of funds to the other taxing jurisdictions. Phil pointed out the cash flows.

TID No. 6 is reported on. Phil reported on the activity in TID No. 6 and that it could stay open until 2029. Phil pointed out that TID No. 6 will have some challenges. TID No. 7 and 8 were created previously and their reports are due next year. TID No. 7 contains JW Speaker and TID No. 8 contains Briggs and Stratton. So far so good on both of those.
